**Plan of Dissolution**

**Section 1.1. Liabilities.** Upon dissolution all liabilities and obligations of the corporation will be paid and discharged.

**Section 1.2. Remaining Assets.** Since FAC is not a charitable or religious organization, remaining assets upon dissolution will be returned to contributors of the assets in the ratio of their contribution. Contributors may elect to have FAC contribute their share of the remaining assets under the provisions of North Carolina and Federal law to another non-profit corporation

**ATTACHMENT 2****FAIR ANNEXATION COALITION  
(FAC)****ARTICLES of INCORPORATION****Purpose**

**Organization.** The Fair Annexation Coalition (FAC) is an organization formed to promote the legal rights of all property owners in the State of North Carolina in their effort to thwart the forced, involuntary annexation of communities by municipalities.

**Permitted Activities.**

- 1) Operate to educate all North Carolina property owners on the issues surrounding forced, involuntary annexation by municipalities and the steps that any property owner may take to oppose such annexation.
- 2) Promote and defend the legal rights of all property owners in the State of North Carolina.
- 3) Assist any property owner with educational materials for use in presentations at public hearings affecting forced, involuntary annexation.
- 4) Collect non-tax deductible donations from interested parties to defray expenses incurred by FAC in the course of conducting approved activities.

**Prohibited Activities.**

- 1) Direct or indirect participation or intervention in political campaigns on behalf of or in opposition to any candidate for public office is prohibited.
- 2) Dues will not be collected as North Carolina property owners are free to participate or not participate in support of FAC.
- 3) Assessments for expenses will not be made. Property owners are free to make non-tax deductible contributions to defray expenses incurred by FAC.
