THIS IS A E-MAIL REQUEST. A HARD COPY WILL BE MAILED TO THE CLERK OF THE COMMISSIONERS

As representatives of the Dutchman Downs Homeowners Association, We respectfully request the following:

Given the fact that Item #6 (the Town of Cary Southeast ETJ request) was removed by the commissioners from your agenda at your November 18th meeting, and understanding that this item may be re-presented and any meeting in the future, we of the Dutchman Downs Homeowners Association (DDHA) request that the Wake County Commissioners:

A: Notify Mr. Ron Thoreson ([Ron@anecorp.com](mailto:Ron@anecorp.com)) 303 2666 DDHA Board Member, Mr. Jed Packer ([jpacker@firstclassautomotive.com](mailto:jpacker@firstclassautomotive.com)) 362 0641 DDHA President, and Mr. Deo Garlock ([deo.mplus@earthlink.net](mailto:deo.mplus@earthlink.net)) 303 9704 DDHA Notification Coordinator, when this issues has been placed back on the agenda for consideration. We understand that agenda meetings are the Wednesday prior to the Monday Board Meetings. We request notification no later that Thursday noon prior to the Monday Board Meeting. We also understand that next weeks agenda meeting is Tuesday with Wednesday being a governmental holiday. We request notification next week by the close of business hours on Tuesday, should this issue be place on the agenda for the December 1st Meeting

B: Place on the agenda immediately prior to this issue a spot which allows a presentation by up to 3 representatives designated by the DDHA to publicly speak to the commissioners about this issues during the Board Meeting. If it is a concern of the commissioners that such placement of a spot for such presentation

would set a bad president, we respectfully then request that the commissioners assure us that they will consider suspending the rules of order in this case in order to hear our presentation prior to action on this item. We understand that items normally referred are not usually allowed public comment, but we argue that the assumption of a vote for referral assumes the commissioners position before a vote is taken. We feel that our presentation could possibly help in this request being denied and therefore referral and work by those governmental professionals who do such work after referral may be avoided.

C: If this issue is to be sent back to the Town of Cary with instructions for re-presentation, we request the same notification as A: above

D: If this item is to be dropped and not considered at all ever without presentation of a new request from the Town of Cary we request the same notification as A: above
